Dear Sir,

With reference to your letter dated 23.10.79, I have been directed to convey sanction of the 'Appropriate Authority' for permanent recognition/affiliation to the abovesaid school for All-India Secondary School Examination and All-India Senior School Certificate Examination w.e.f. 1.5.1981. The recognition/affiliation has been granted in pursuance of the Gazette Notification No. SO dated 1.9.1979 issued by the Government of India, Ministry of Education and Social Welfare designating the Central Board of Secondary Education, New Delhi, as an 'Appropriate Authority' under Delhi School Education Act, 1972 in respect of the schools in the Union Territory of Delhi which may prepare candidates for Board's All-India Secondary and Senior School Certificate Examinations.

The sanction is subject to the fulfilment of the following conditions:-

1. The school will follow syllabi and courses as per scheme of studies prescribed by the Board for All-India Secondary School Examination and All-India Senior School Certificate Examination and the changes made therein from time to time.
2. The school shall appoint only qualified and eligible staff, if required.
3. Service agreement shall be executed. Services of any employee of the school shall not be terminated without the prior approval of the Competent Authority.
4. Service conditions, Pay Scales & other Allowances i.e; C.C.A., H.R.A., D.A. etc; and other benefits to the employees of the school shall in no way be less than corresponding employees working in Government schools of the Union Territory of Delhi announced from time to time.
5. The school and its records shall be open for inspection by any authorised Officer as may be nominated by the Board. The school shall also furnish informations as may be asked for by the Board from time to time.
6. The school shall not run on profit basis nor for accruing any advantage to a person or group of persons.
7. The school premises or the property shall not be used for commercial or residential purposes (except where staff quarters are there)

or for communal, political or non-educational activities of any kind whatsoever.

8. The rates of tuition and other fees shall not be enhanced without prior permission of the competent authority.
9. The admission to the school shall be open to all without any discrimination on the ground of religion, caste or race, place of birth or any of them.
10. No unrecognised classes shall be run within the premises of the school.
11. The school will follow the inter-school rules.
12. The school will help the Board in the smooth conduct of the examinations by placing the necessary accommodation i.e; Halls, Rooms available in the school premises and furniture at its disposal for holding its examination, free of charge, if required to do so.
13. The school will spare sufficient teachers for invigilation purposes at the examinations of the Board as may be required by the Board.
14. The school shall follow the instructions laid down by the Board from time to time and abide by all the rules and regulations of Delhi School Education Act, 1973.

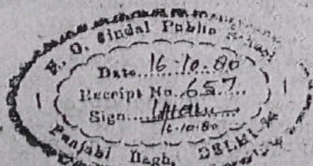
